MAY 9, 2023 BATTLE CREEK, IA

The Battle Creek City Council met in regular session on Tuesday, May 9, 2023, at 6 p.m. at the Community Hall. Mayor Pierce presided over the meeting. Council members present: Jary Vermeys, Myra Meek, Jeanette Holmes, Kevin Dausel and Jill Wingert.

Mayor Pierce called the meeting to order. The clerk noted that the privacy fence in last month's minutes should have read 704 5th Street instead of 507 Maple. Motion by Vermeys, seconded by Meek to approve the agenda and meeting minutes with the noted correction. Motion carried unanimously.

The council discussed nuisances. 102 Main Street has been resolved, 406 Clara Street has not complied, 305 5th Street is awaiting court ordered clean up.

by Holmes to recommend approval of an IDOT Application of Highway Right-of-Way for Utilities accommodations for Sac County Mutual Telephone Company. Motion carried unanimously.
