

# PROCEEDINGS: IDA COUNTY BOS • MARCH 14 MINUTES & CLAIMS

## IDA GROVE, IOWA MARCH 14, 2023

The Board of Supervisors convened in adjourned session, members present Chair Creston Schubert, Raymond Drey and Devlun Whiteing.

Minutes of the meeting held Feb. 28, 2023 were read and approved. It was noted that Andy Preston previously approved as a part-time as needed Jailer/Dispatcher retracted his employment commitment before starting his position.

County Engineer Jeff Williams presented a Tile Road Crossing Application from Kim Conover Section 30 and 19 in Logan Township. Whiteing moved to approve and authorize the Chair to sign said application. Drey seconded the motion and it carried, all voting Aye.

Morris Hurd, Treasurer of the Ida County Historical Society was present to request extra county funds for maintenance on the historical buildings located in Ida Grove and Moorehead Park. Discussion was held on allocating an additional \$500. No official action was taken.

Discussion was held on the proposed FY-24 County Budget. Due to proposed State Legislation, Senate File 356 on limiting values for taxation and utilizing FY-24 budget as a base year, the Board proposed increasing levies to compensate for loss revenue for the FY-25 budget and expenses due to inflation. Whiteing moved and Drey seconded a motion to set the Budget Hearing for the Proposed FY-24 Budget for April 11, 2023 at 10:30 a.m. Details of the proposed budget will be published on March 22, 2023.

Drey moved to approve and authorize the Chair to sign Resolution 23-6 Destruction of Weeds. Whiteing seconded the motion and it carried, all voting Aye. Details of Resolution 23-6 are on file and may be reviewed in the Auditor's Office or on the idacounty.iowa.gov website.

Whiteing moved to approve the resignation of Deputy Sheriff Alex Ehlers, effective March 19, 2023. Drey seconded the motion and it carried, all voting Aye.

A motion by Drey and seconded by Whiteing to approve Claudia Comstock as Ida County Assessor with a salary of \$85,000 effective Feb. 24, 2023. Motion carried, all voting Aye.

A motion to approve and authorize the Chair to sign Change Order #4 Relocating condensation line, 2 air lines to thermostat and water lines found in the Supervisor's Room for \$5,466 from Holstein Electric was made by Whiteing and

seconded by Drey. Motion carried, all voting Aye.

Change Order #5 for skim coating walls, was tabled.

A motion by Whiteing and seconded by Drey to approve and authorize the Chair to sign change order #6 new gutters and downspouts in the amount of \$48,308 from Suter. Motion carried, all voting Aye.

Whiteing moved to re-appoint Robert Welte, Joyce Schnabel and Corey Trucke as Medical Investigators for a 2 year term ending 03/31/2025. Drey seconded the motion and it carried, all voting Aye.

Drey moved to increase compensation of Medical Investigators from \$100 to \$200 per investigation and Medical Examiner from \$250 to \$350 per incident-effective July 1, 2023. (Corey Trucke would be exempt from these fees) Whiteing seconded the motion and it carried, all voting Aye.

A motion by Whiteing and seconded by Drey to approve the resignation of part-time Jailer/Dispatcher Norma Nichols effective March 21, 2023. Motion carried, all voting Aye.

The Board acknowledged receipt of manure management plans from Cozy Valley Farms, LLC-Site #3 and Fertig Farms #2 and #3.
