Call to Order - President Rasmussen called the meeting to order at 5:30 p.m. The board recited the Pledge of Allegiance. Second by Loger. Ayes: 5. Nays: 0. Motion Carried.

Approve Dropout/At Risk Prevention Plan - Goodman moved to approve the At Risk/Dropout prevention plan for OABCIG Schools for the 2023-24 School Year. Second by Jacobson. Ayes: 5. Nays: 0. Motion Carried.

Confirm Dates and Time of Next Meetings - The next regular meeting will be held Monday, Jan. 8, 2023, at 6:30 p.m. in the boardroom at the high school.

It was moved by Goodman and seconded by Loger to adjourn. The motion carried 5/0 and the meeting adjourned at 6:15 p.m.
