City of Ida Grove Council Meeting Minutes Monday, Dec. 18, 2023 5:30 p.m. Temporary City Hall

311 Barnes Street 1. Call to Order: Mayor Nathan Weitl called the meeting to order at 5:30 p.m. 2. Roll Call: Present: Gregor Ernst, Jeff Miesner, Jason Schable & Ange Johnson. Jared Bogue was absent at this time. 3. Approval of Agenda: Motion by Ernst, second by Schable to approve. Motion carried 4-0. 4. Consent Agenda: Motion by Ernst, second by Miesner to approve the consent agenda consisting of the following: Clerk's Report, claims in the amount of \$339,589.66, financials, minutes of the 12/4/2023 meeting, Family Dollar Class B Alcohol License effective 12/21/2023 & permits. Motion carried 4-0. 5. Second Street Business District Parking Concerns: Bogue arrived at this time. Many parking concerns and complaints are being brought to the attention of City Hall. Sweeden reported it is great that downtown businesses are thriving and some vacant buildings are being filled, but naturally, this is causing parking availability issues within the business district, mainly Second Street from Burns to Quimby. Topics thoroughly discussed were as follows: bringing awareness to business owners/employees of the two-hour parking ordinance (9 a.m. to 4 p.m.)

along Second Street from Burns to

Quimby and Main Street from Second to Third by adding signage, utilizing Taylor Street and Noble Parking Lot (behind Ida Grove Hardware) for business owner and employee daytime parking, upper level housing tenants and Airbnb guests shall obtain a parking pass from City Hall and also use Noble Parking Lot for overnight parking, especially during the snow removal season, and address vehicles being parked long term. Council will revisit the topic at a future date, if needed. 6. Main Street Handicap Parking: No action taken. Schable will review ADA Compliance in regards to aisle accessibility and slope. 7. Oath of Office: Weitl, Ernst, Schable, Bogue and McLead all recited the Oath of Office. Schable left the meeting at this time. 8. Contract with Calhoun Burns - 2024 Bridge Inspections, Emergency Vehicle & All Systems Overweight Analysis: Motion by Bogue, second by Miesner to approve Calhoun Burns for 2024 Bridge Inspections \$2,300 and Emergency Vehicle & All Systems Overweight Analysis estimated at \$750. Motion carried 4-0. 9. Resolution 2023-48 Support of Splashpad Project: Motion by Miesner, second by Ernst to approve Resolution 2023-48. McLead brought some items of concern to the council's attention as follows: food truck alley may require to be widened for 2- way traffic, with removal of the existing gravel road for phase 1, plow trucks and sanitation trucks will have extreme difficulty turning around, existing water/ sewer lines should be considered so as not to cover them completely with the proposed splashpad. Additionally, McLead asked how this may affect the City Pool. McLead stated he is not opposed to the plan, but wanted to bring these items to council's attention for consideration. Ernst stated 100% of everything on the master plan must be run through City Council for approval. Bogue will bring these items up to the Foundation at an upcoming meeting. Motion carried 4-0. 10. L & L Builders, City Hall Pay App #8 \$185,660.89: Motion by Miesner, second by Ernst to approve. Motion carried 4-0. 11. City Council Member News & Notes: A Public Hearing will be held Jan. 2 at 5:30 for a rezoning request. Miesner expressed safety concerns with the top tier railing that has been installed at the new City Hall. Bogue confirmed what has been installed is what was approved in the plans and specs. Everyone present thanked Johnson for her service on the City Council. 12. Adjournment: Motion by Johnson, second by Ernst to adjourn at 6:50 p.m. Motion carried 4-0.
