City of Ida Grove Special Council Meeting Minutes Tuesday, July 1, 2025 at 4 p.m. City Hall, 403 3rd Street

Call to Order: Mayor Nathan Weitl called the meeting to order at 4 pm.

Roll Call: Council present: Jeff Miesner, Jason Schable, Reynold McLead, Jared Bogue and Gregor Ernst (arrived at 4:02 p.m). Others in attendance were GOMACO employees David Petersen and Marc Lansink, Ida County Courier's Brent Harm and City Clerk Heather Sweeden. Approval of Agenda: Motion by McLead, second by Schable to approve. Motion carried 4-0. Condition of Property Located at 402 - 408 Second Street: Petersen and Lansink were in attendance regarding the current visual state of the roof of the City owned property neighboring the GOMACO Car Museum; noting the roof appears to be caving in as well as sheets of metal have blown loose and folded over onto the GO MACO property. Sweeden shared Brentwood Roofing and Watertight Roofing were contacted yesterday when the City became aware of the severity of the issue and the City directed for the sidewalk and parking surrounding the building be barricaded off for public safety. Yesterday, June 30th, Brentwood Roofing was able to remove the metal sheeting that had blown onto GO-MACO's roof and attached 2X6's to secure any other metal from blowing off as a short term solution. Petersen and Lansink explained they have concerns regarding the parapet wall between the two buildings which appears to now be leaning as well as scratched paint on the GO-MACO roof. Bogue inquired about the DNR Derelict Building Grant, specifically if they offer an emergency application period for funding assistance. Sweeden will contact them to find out as applications are normally due in February. Council directed for Sweeden to contact an engineering firm to conduct another structural analysis to determine the building's current state of failure risk to adjoining properties, options to remedy the situation (both short term and long term) and if the building shares a wall or walls with neighboring properties. Council will discuss the situation further at the regularly scheduled July 7, 2025 meeting. Other Business: None. Adjournment: Motion by Ernst second by Miesner to adjourn at
