City of Ida Grove Council Meeting Minutes Monday, May 6, 2024 • 5:30 p.m.

City Hall, 403 3rd Street 1. Call to Order: Mayor Pro Tem, Gregor Ernst, called the meeting to order at 5:30 p.m. 2. Roll Call: Present: Gregor Ernst, Jason Schable, Reynold McLead & Jared Bogue (arrived at 5:35 p.m.). Mayor Nathan Weitl and Councilman Jeff Miesner were absent. Guests in attendance: Brian Lundell, Mary Morgan, Kelsey Vetter, Ethan Joy & Wendy Jepsen. 3. Approval of Agenda: Motion by McLead, second by Schable to approve. Motion carried 3-0. 4. Kelsey Vetter - City Hall a. Official Change Order #18 \$5,500: In November, a heated enclosure was placed around the North and West sides of City Hall to allow for efface installation, which requires a temperature not less than 40 degrees for proper curing. This \$5,500 change order includes L&L's costs with no markup. Motion by Ernst, second by McLead to approve. Motion carried 3-0. b. L & L Builders Pay App #12 \$65,672.09: With approval of pay app #12, the project is 100% paid with the exception of \$94,413.63 in retainage. Motion by Ernst, second by McLead to approve. Motion carried 3-0. Boque arrived at this time. 5. Brian Lundell - Marketing Campaign Proposal: Lundell presented information for a marketing campaign proposal to promote Ida Grove as a great place to visit, live and work. Lundell inquired if City Council has interest in being a part of the campaign which consists of commercials aired on both KCAU and KTIV. There is a substantial financial commitment of about \$38,000 total. Lundell stated there is a grant the

City could apply for to help cover

a portion of the costs. Lundell also

intends to speak to business own-

ers for sponsorship, but hopes for

half of the financial requirement to

come from the City, with the City

also taking the lead on the project.

Lundell will come back to council

in a couple months with additional

information. 6. Isaac Schmidt -

Line Replacement: Schmidt was not in attendance; no action taken. 7. Wendy Jepsen - Street Closure Request for June 8, 2024: Jepsen stated she spoke with all affected business owners on Second Street between Quimby and Taylor; none having any objections to the street closure request. Jepsen understands she is responsible for picking up and returning barricades. Motion by Bogue, second by McLead to approve the request for street closure on June 8, 2024 for a Simply Summer Block Party. The closure is approved from 6:30 a.m. to 11:59 p.m. Motion carried 4-0. 8. Consent Agenda: Motion by Ernst, second by McLead to approve the consent agenda consisting of the following: Clerk's report, claims in the amount of \$507,932.31, financial reports, minutes of the 4/15/2024 meeting, 5-day special event retail alcohol license for Lucky Wife Wine Slushies effective June 4 to June 8, 2024, class E retail alcohol license including automatic renewal for Discount Liquors effective June 1, 2024, permits and correspondence. Motion carried 4-0. 9. 2024 Hay Bids - Open & Award: Four hay bids were received as follows: Gaylen Wunschel \$46/bale, Lyle Schumann Sr. \$66/bale, Scott Neumann \$60/bale, Matt Dirksen \$58/bale. Motion by McLead, second by Bogue to approve the bid from Lyle Schumann Sr. Motion carried 4-0. 10. Water Project Update: Staff recently met with JEO to discuss water discoloration and chlorine smell after introducing new well #9 into the distribution system. Joy explained during the test well phase, well #9 came back with elevated iron levels. At that time, it was explained well #9 wouldn't be the best option to run by itself without a treatment plant, but would be safe for drinking. Well #9 was intended to blend with well #8 to provide more capacity and avoid building a treatment facility. Test results from wells #8 and #9 blended are good and meet EPA and DNR regulations. Joy stated the discoloration is likely due to sediment deposits being stirred up, that were already in the pipes, as

well as the chlorination process oxidizing the iron and causing a brown/ orange color. Joy further stated the polyphosphate is set ahead of the chlorine injection with enough distance that it should provide ample amount of reaction time to sequester iron before chlorine injection. Joy stated the importance of flushing the system on a regular basis, noting public works concern with this due to faulty valves and hydrants within the system as well as low pressure concerns in Zobel's Addition. It was also noted the City is unable to do any flushing at this time with the water tower being empty for painting. Currently, the City is only using well #8. 11. Iowa DOT Recommendation for 3-Lane Highway: An Iowa Department of Transportation representative contacted City Hall last week and stated they're going to be letting a project this Fall to diamond grind Highway 175 through Ida Grove. The IDOT recommends the City Council consider changing the highway from a 4-lane to a 3-lane for safety reasons. IDOT would like to attend a council meeting to present information to council. A meeting with IDOT will be scheduled.

12. Levee Slip Line: Inspection of Odebolt Creek RB & Maple LB identified heavy corrosion and large joint separation of a 54" diameter pipe at the drainage structure station North of Cobb Park. Council provided a nod of approval to prepare contract documents with JEO to slip line the pipe. 13. Street Closure Request Process: Council will review at a future meeting. 14. City Council Member News & Notes: Ernst stated he received a complaint from a citizen regarding vehicular line of sight when stopping at the intersection of Third/Main Street heading West. 15.
