City Hall, 403 3rd Street Call to Order: Mayor Nathan Weitl called the meeting to order at 5:30 p.m. Roll Call: Council present: Gregor Ernst, Jeff Miesner, Jason Schable, Reynold McLead and Jared Bogue. Others in attendance were Stephanie Konradi and City Clerk Heather Sweeden. Approval of Agenda: Motion by McLead, second by Bogue to approve. Motion carried 5-0. Consent Agenda: Motion by Ernst. second by Schable to approve the consent agenda consisting of the following: Clerk's Report, claims in the amount of \$349,287.86, financials, minutes of the 8/4/2025 &8/11/2025 meetings, permits and correspondence. Motion carried 5-0. Resolution 2025-40 Approving FY25 Street Finance Report: Motion by McLead, second by Ernst to approve and authorize submission to the Iowa DOT. Motion carried 5-0. Nelson & Rock Contracting, Levee Slip Line Project Pay App #2 \$11,561.50: Motion by Bogue, second by Ernst to approve. Motion carried 5-0. Approve Payment to Bedrock Gravel, Inc. for Emergency Demolition of 402-406 Second Street \$205,000: Motion by Ernst, second by Miesner to approve. Motion carried 5-0. Sewer Improvement Project Planning & Design Loan Repayment \$475,306: Mo-

tion by Bogue, second by McLead to pay the outstanding loan bal-ance of \$475,306 to Iowa Finance Authority for Sewer Improvement Project Planning & Design Loan #1 from sewer cash reserves. Motion carried 5-0. E. Second Street, Project Update: Driveways and shoulder work must be completed in order to reopen the street. Council shared concerns if the street is not open by the first day of school, Aug. 25. E. Second Street - Detour Route, Parking Concerns: Traffic flow concerns, especially on Barnes Street, and safety issues were discussed as potential issues if the street is not open by Monday, Aug. 25 in time for the first day of school. Motion by Miesner, second by Bogue to prohibit street parking along the detour route beginning on Monday, Aug. 25 until the E. 2nd street project is completed and the road is reopened. Motion carried. 5-0 Cyber Security Enhancements: Motion by Bogue, second by Ernst to approve and accept the enhanced cyber security services agreement with Secur-Serv at an additional \$24/month. Motion carried 5-0. Zimmy's Lift Station Pump Replacement: Council reviewed quotes from Electric Pump \$14.560 and Iowa Pump Works \$14,400 for replacing two lift station pumps due to failure. Motion by McLead, second by Miesner to approve the quote from Iowa Pump Works. Motion carried 5-0. Compost & Brush Piles - Security System: Council continued discussion around installing an updated security system. Council directed for additional information to be obtained and for staff to move forward with updated signage. No official action was taken. 402-406 Second Street Post Demolition Direction: Costs for bracing the remaining wall at 402 Second Street were not available at the time of the meeting; no action taken at this time. 408 Second Street Direction: A recent email from Bill Murphy, JEO Consulting, indicated there is a 20 foot section of roof that is in a progressive roof collapse condition, due to broken trusses, likely from impact type loading from demolition of the neighboring building. The City has not received the official engineering report at this time. Motion by Ernst, second by McLead to begin the process of advertising the sale of 408 Second Street. Motion carried 5-0. City Council Member News & Notes: Ernst relayed a citizen concern regarding kids and electric scooters, Schable inquired about the hav cutting contract, Sweeden updated council regarding software training, a dog attack on chickens and reminded those in attendance that election filing begins Aug. 25. Adjournment: Motion by Bogue, second by Schable to adjourn at 7:16 p.m. Motion carried 5-0.
