City Hall, 403 3rd Street Call to Order: Mayor Nathan Weitl called the meeting to order at 5:30 p.m. Roll Call: Council members present: Gregor Ernst, Jeff Miesner, Reynold McLead & Jared Boque, Jason Schable was absent. City Clerk Sweeden and Attorney Reininger were present. Approval of Agenda: Motion by McLead. second by Ernst to approve. Motion carried 4-0. Jason Butler & Nick Lahrs - Water & Sewer Affidavit Operator: As a result of the recent resignation of Lucas Collins, proposals were requested to fulfill the lowa Department of Natural Resources requirement to have a Grade II Water Distribution & Treatment Operator and Grade II Wastewater Operator to submit reports and provide direction. Butler presented on behalf of his company, JBE. Butler stated his proposal includes weekly on-site visits and daily communication with staff regarding readings and system data. Butler provided his quote and agreement terms to Sweeden at the end of his presentation for distribution to council for their review. No decisions were made and the topic will be reviewed at the next regular meeting. Tom Grafft & Eric Driver. ISG Engineering - Water & Sewer Affidavit Operator: Grafft pre-sented a proposal to fill the IDNR requirement to have a Grade II Licensed Water and Sewer Operator. Grafft has been employed with ISG Engineering out of Storm Lake for 24 years and noted the company has several qualified operators on staff, in addition to two former IDNR employees. Grafft's proposal includes weekly onsite visits, communication with staff and delivery of samples to the laboratory. Council will review the proposal and agreement provided for discussion and

decision at the next meeting. Angela Scales, Library Director -Annual Report: Scales presented the FY2025 Annual Library Report highlighting programs offered, projects completed and a financial overview. Council thanked Scales for her hard work and dedication to the Library. Nathan & Jessi Oldham - Great Dane Compliance: Following a 6-month probation period implemented in June 2025, council reviewed the terms of the compliance plan. No further instances of attacks have been reported, a fence was erected and proof of completion of an obedience class was provided. All terms of the agreement were met; thus the Oldham's great dane will not be deemed vicious at this time. No action taken. Owen Bolte - Ida Grove Economic Development Corporation, City Park Developments: Bolte provided council information regarding overall splash pad project costs and noted there are remaining funds available from the project. The IGEDC intends to set aside about \$25,000 for the City to use towards any needed future repairs. The committee is now ready to start fundraising for phase , which includes a larger shelter house, bathrooms, parking and sidewalk improvements. Bolte will present updated plans to the council at a future meeting. Consent Agenda: Motion by Ernst, second by McLead to approve the consent agenda consisting of the following: clerk's report, claims in the amount of \$148,784.62, financial reports, minutes of the 12/1/2025 meeting, ownership updates for Casey's retail alcohol license and correspondence. Hire Subcontractor for 2025-2026 Snow Removal Season: Snow removal bids were received and opened from Ladwig Construction, Rehse Construction, Smith Construction and Nathan Arbegast, Bidding documents included 12 loca-

Bid awards were granted based on the lowest bidder, per location with the expectation of snow being cleared within 24 hours of the snowfall ceasing and a onetime push per snow event. Ladwig was the low bidder for the following locations: sidewalks at 301 Moorehead Street, Washington Street Bridge, Moorehead Avenue Bridge, 7th Street Bridge, Godbersen Park and the demolished Castletown Brewery for a total of \$210 per event. Rehse was the low bidder for the following locations: parking lots & sidewalks at the Rec Center, Library, Swimming Pool, Noble Parking Lot, City Hall and the Fire Station for a total of \$880 per event. City Council Member News & Notes: Sweeden provided the 2026 Standing Committees & 2026 City Council Meeting Schedule. Sweeden, Weitl, Behrendsen & Miesner took the Oath of Office. Sweeden updated council that the Ida Grove Foundation would like the City to continue ownership of 411 2nd Street in order to apply for another round of grants.
